Overview of hazard or threat:

Modern food chains are extended. The likelihood of the effects of contamination are further extended by people travelling widely in an area, buying food and taking it back with them or because of the effects of food being centrally produced and transported relatively long distances to many areas. Furthermore - even with the highest standards of hygiene it is a possibility that food will accidentally be contaminated. Occasionally the effects of food contamination can spread within the population - requiring a health-based response.

Key historical evidence:

2009 - E Coli outbreak pies in Wales

2011 - Contaminated fenugreek sees - E Coli outbreak

2013 - Horsemeat contaminated beef burgers

June 2014 – FSA statistics: 500,000 cases of food poisoning a year from known pathogens. Double this number of incidents caused by unknown pathogens.

Controls in place

Local authorities rigorously inspect and regulate food production facilities. Facilities exist for the swift testing of food - which helps to identify the containment and assists the NHS in its response to the incident. Local and National authorities can act swiftly to stop the distribution of contaminated food - or even food considered to be contaminated. Strong links exist with colleagues in the media who can be asked to broadcast public information messages. Plans exist (based on past incidents) on how to deal with incidents concerning contaminated food. Food Hazard Alert system - from Food Safety Act 1990 Code of Practice.

Food Standards Agency - (widespread - if beyond District boundary) and Local Authority Environmental Health Department (local / widespread). Local Authority Food Inspections. Local Authority Education and Advice.
